Pledge of Allegiance was said. Roll call was taken Supervisor Gerald Wenkel, Treasurer Judy Bell, Clerk Ardith Demo, Trustee Marcella Ruzala, and Trustee Noreen Walter. Minutes from the March meeting were presented and read.

Correspondences were read. Treasurer’s report submitted by Judy Bell. Motion made by Walter to approve Treasurer’s report as presented. Seconded by Ruzala. Motion carried. Motion made by Ruzala to pay the bills as presented. Seconded by Walter. Motion carried.

A Planning Commission Meeting Public Hearing will be held April 27, 2022 for the purpose of a special use permit request from Mitchell and Susan Oliver to operate a boarding kennel at 4400 M-61, Standish.

The Planning Commission will hold a Public Hearing April 27, 2022 to hear a proposal on a Special Use Permit from Johnsfield Solar L.L.C. They are proposing a 10-megawatt alternating current Solar Energy Facility. Board of Review held with one change and one poverty exemption excepted March 14 & 15.

Road Commission Meeting held with Lincoln Township on March 17, 2022. A motion was made by Bell to do road improvements. A motion was made by Walter to except bid for a new sign at the hall with a notification board. The bid is for \$1,500.00. The project money to be used from ARPA. Seconded by Ruzala, Motion carried.
