

**Lincoln Township – Regular Meeting  
June 9, 2022**

The regular monthly meeting of the Lincoln Township Board was held at the Lincoln Township Hall and called to order on this date at 6:00 P.M by Supervisor Gerald Wenkel. Pledge of Allegiance was said. Roll call was taken Supervisor Gerald Wenkel, Treasurer Manda Haas, Clerk Ardith Demo, Trustee Marcella Ruzala, and Trustee Noreen Walter. Minutes from the May meeting were presented and read.

Correspondences were read. Treasurer's report submitted by Manda Haas. Motion made by Walter to approve Treasurer's report as presented. Seconded by Ruzala. Motion carried. Motion made by Walter to pay the bills as presented. Seconded by Haas. Motion carried.

Meeting open to the public at this time with nine interested citizens present. Paul Golimbieski has a bid for road side mowing. \$46.00 per mile with a \$40.00 surcharge for fuel. People representing Townline Road west of Deep River would like to have Townline Road maintained.

Fire Authority report given by Ruzala for April and May. Next meeting June 28, 2022.

Zoning report given by Brenda Matt.

A special planning committee meeting held May 25, 2022 for Solar Project. Motion made by Demo to approve Resolution recommending approval, from Planning Commission, of the site plan and the conditional use permit for The Johnsfield Solar Project accessed from Johnson Road. Seconded by Haas. Roll call vote Wenkel aye, Haas aye, Demo aye, Ruzala aye, Walter aye. 5 aye 0 nay Resolution adopted. 06092022-1. the project will have decommissioning cost without salvage, to be reevaluated every 5 years for inflation.

A motion was made by Demo to have Paul Golimbieski do road side mowing at the bid price. Seconded by Ruzala. Motion carried. The Planning Commission feels they were shorted a meeting payment. Discussion tabled until July.

Townline Road repair tabled until more information can be obtained from Arenac County Road Commission and Deep River Township. Eastern Dust Control has brine being put down on gravel roads. A motion was made by Walter to increase garbage tax from \$154.00 annually to \$180.00 per garbage resident to start December tax bill 2022. Seconded by Haas, Motion carried.

Motion made by Walter to have Lincoln Township Treasurer, Manda Haas, to acquire a debit card for Verizon Telephone and hot spot to be paid with name change and address. Seconded by Ruzala. Motion carried.

Lincoln Township to host MTA meeting in July at Deep River Township Hall. A budget of \$300.00 was approved.

Motion to adjourn made by Ruzala. Seconded by Demo. Meeting adjourned at 7:45 P.M.
